We are accepting applications for vendors offering unique arts and crafts items, hand-made local goods, and information booths for service and food. This is a family-oriented event, adult-natured and/or vulgar items will not be accepted. The board of directors for the Gulf Coast Association of Pride reserves the right to make final decision on acceptance of vendor application based on space availability and applications will be approved on first come/first served basis.

#### **VENDOR SPACE and FEES:**

Craft or business booth:	10 x 10	\$ 50.00
Food or other edible booth:	10 x 10	\$ 100.00
Larger than 10x10	truck	\$ 200.00

\*\*\*Electricity is for food vendor only and is \$ 50.00 per 110-outlet. ONLY 10 SPOTS IF AVAILABLE\*\*\*

Non-Profit organization information only booth – NO FEE but limited space available

\*\* Multiple spaces may be purchased for larger vendor spaces (example 2 10x10 is \$ 100.00)

\*\* FOOD VENDORS MUST HAVE FOOD PERMIT OR LIABILITY INSURANCE and must be with application. \*\*

#### **GENERAL RULES:**

Vendors must accept ASSIGNED SPACE as given. Set-up is between **8:00am and 9:00 am FOR FOOD VENDORS ONLY**, 9:00AM TO 11:00am FOR ALL OTHERS the day of event. There will be no driving on the grass areas: utility carts, wagons, etc. may be used to transport items to booth from the parking area. Vendors are responsible for policing their own area. We will not be responsible for lost, stolen or damaged goods. Your assigned area must be left clear of garbage, debris, stains upon exit. Vendors may sell only items listed on their approved application. We reserve the right to decline items being sold.

#### **APPLICATION PROCESS:**

- 1. Complete application and mail with payment (check or Money Order)**
- 2. Check / Money Order made out to: GULF COAST ASSOCIATION OF PRIDE**
- 3. FOOD VENDORS MUST ATTACH COPY OF FOOD PERMIT OR LIABILITY INSURANCE**
- 4. Application will be reviewed for approval or denial**
- 5. Once approved, an email will be sent to the applicant along with assign booth space prior to event**
- 6. Deadline for applications will be June 1, 2021**
- 7. NO REFUNDS WILL BE GIVEN FOR CANCELLATIONS**
